Oregon 99: Glenwood Road to Coleman Creek

Construction Phase

Region 3: Southwestern Oregon (Medford, Phoenix, Jackson)

This phased project will keep the existing 5 lane section and widen the highway to provide needed bike lanes and sidewalks on both sides of the roadway. Crosswalks and crossing islands will also be constructed along with enhanced transit stops.

Impacts

Traffic Impact

Currently there is utility relocation on going through Summer 2024. This means traffic control: single lane traffic, controlled by flaggers at times.

Accommodations are being made to keep business access and driveway access to residents open.



Benefits

When complete this project will improve livability in the corridor by enhancing safety and mobility for all users including bicyclists, pedestrians and transit users on this busy Oregon 99 corridor between Phoenix and Medford.

What Problem Will This Improve?

- This project hopes to be a partner in the Almeda Fire rebuilding process so when housing returns, safer transportation features will be available to residents.
- The loss of housing for low income, senior, veteran and Spanish-speaking residents was a blow to the community.
- Several mobility challenged individuals ride their scooters off the shoulder or in the travel lane.
- Even with an existing RVTD route through this area there is poor access to the current transit stops.
- The lack of pedestrian and bike amenities are a safety problem. There is a record of frequent fatal and serious injury crashes in this corridor, even with enhanced lighting and lowered speed limit.

INTRODUCTION

The purpose of this memo is to transmit a succinct statement of purpose and need for the proposed South Stage Road Extension planning project. ODOT is preparing a Facility Plan to evaluate potential transportation improvements across Interstate 5 (I-5) between the Phoenix interchange (at Exit 24) and South Medford interchange (at Exit 27) in south Medford, Oregon. The Facility Plan analysis will be based on a Year 2045 planning horizon. Contained in this memo are the following scope items:

- A clear and succinct statement of the proposed action's purpose expressed as a desired transportation outcome that identifies the fundamental reasons why the action is being proposed; and
- A brief description of the problems that the proposed action is intended to address and, to the extent possible, an explanation of the underlying causes of those problems.

Specific supporting data to fully demonstrate the proposed action's needs and documentation of agency and public participation and input have not yet been completed. Future Technical Memorandums *4.1.1.3B Final Existing Condition Summary* and *4.1.2B Final Future Year Traffic Analysis Summary* along with PMT, PDT, PAC, and community feedback will ultimately confirm the needs. The initial draft of this memo has been reviewed by the Project Development Team (including FHWA staff) and their suggested changes have been incorporated. This memo will be used to generate additional feedback from agencies and the public during initial outreach activities.

According to the Federal Highway Administration (FHWA), a Purpose and Need Statement should focus on the transportation problem (or problems) to be addressed by the proposed action. It establishes why the agency is proposing to spend taxpayers' money while at the same time causing potential environmental impacts. The Oregon Department of Transportation (ODOT) recommends that the Purpose should define the transportation problem to be solved, and the Need discussion provides data to support the Purpose. The Purpose and Need is the basis for developing methods and criteria for narrowing the range of alternatives to be carried forward into the NEPA process (see attached *Tech Memo #2.1.3: Goals, Objectives, Evaluation Criteria, and Performance Measures* for further information). Purpose and Need


The purposes of the South Stage Road Extension project are to: (1) reduce out of direction travel by improving east-west multimodal connectivity across Interstate-5; (2) to reduce existing and projected congestion and related traffic safety issues in the vicinity of the Interstate-5 interchanges with Garfield St. and N. Phoenix Rd. and the adjacent local street network; and (3) support local system improvements associated with current and planned land uses as well as improved emergency preparedness in the rapidly urbanizing area of south Medford, Oregon and north Phoenix, Oregon. The following transportation needs (problems) have been identified:

Interstate-5 (I-5) creates a barrier to local east-west travel that limits local road connectivity resulting in out of direction travel and poor east-west travel times. No transportation facilities cross I-5 and the parallel Bear Creek Greenway between Exits 24 and 27, a distance of approximately 3 miles. Because of this lack of local arterial road connectivity across I-5, east-west travelers including transit users must traverse to either the Phoenix interchange or the South Medford interchange (via Barnett Road and Garfield Street) resulting in inefficient out-of-direction travel and excessive travel times, which increases economic costs for businesses and travelers. For people walking and biking, travel times are even longer. The lack of connectivity and intersection related congestion can be particularly serious for medical emergency response times with Asante Rogue Regional Medical Center located along Barnett Road east of I-5.

Lack of east-west connectivity across I-5 is a primary contributor to congestion and traffic safety issues at the interchanges and the local roads accessing the interchanges. The South Medford interchange is one of the most congested areas in Medford. Because the east-west arterial network concentrates traffic at the arterial streets that do cross I-5 (Phoenix Road, Garfield Street, and Barnett Road) those interchanges, and local street networks, are currently and/or projected to be overcapacity and include intersections identified in the Safety Priority Index System (OR99/Stewart Avenue, OR99/Garfield Street, and I-5/South Medford Interchange). At the South Medford interchange, congestion is causing a bottleneck with southbound queues spilling back onto the I-5 mainline, which is not just a congestion issue, but also slows freight access to I-5 and causes safety concerns for potential high-speed, rear-end collisions.

Improved east-west arterial connectivity is needed to support planned growth in the Medford and Phoenix urban growth reserves. South Stage Road has long been planned as a primary east-west route across the Rogue Valley and it is the only arterial between the two interchanges that provides east-west connectivity from the City of Jacksonville and other areas within Jackson County to Highway 99. Local, adopted land use and transportation system plans identify an extension of South Stage Road as being needed to support future residential and regional employment land development in the south Medford and north Phoenix areas east of I-5. Providing additional east-west connectivity could also improve emergency response times and opportunities for egress during an emergency event (e.g., wildfire, flooding).

CURRENT ACTIVITIES

Construction

The contractor continued to make progress during the month of February. During this time, they poured auxiliary parking components for the east parking lot. This includes a concrete apron, curbs, sidewalk components and stem walls for the rain garden. Flooring installations within the facility continued to progress with the Police Department offices receiving carpet tile and floor base. Flooring at the second-floor Fire Department and City offices have begun as well. Lighting fixtures and ceiling cut-ins have progressed as the contractor looks to drop ceiling tile at the second floor soon. Drywall finishing activities have begun in the apparatus bay, following the drywall installation process. The contractor continues to install case work, marker, and glass boards as well as toilet accessories, doors, and hardware. They continue their diligent work towards substantial completion and building construction.





SUMMARY

Lynn Cohen, acting on behalf of the Phoenix Grange, is requesting authorization to retain an approximately 60-square foot mural on the front of the Phoenix Grange building, located at 209 N. Main Street, for a period 10 years.

BACKGROUND AND DISCUSSION

On December 6, 2021, the Phoenix City Council unanimously approved the public art piece as a means of fostering civic pride and resiliency consistent with the standards set forth in Chapter 3.6.11 – Public Art Program, Procedures and Standards of Review.

The Planning Commission, who also serves as the Historic Review Board was tasked with reviewing the installation of the public art piece on a historic building and property. The Planning Commission reviewed this request in accordance with the Phoenix Land Development Code, Chapter 2.7 – Historic Preservation Overlay Zone. Decisions on exterior remodels (or changes to an exterior) were made pursuant to PLDC Chapter 2.7.5. Specifically, their decision was made using the following criteria:

A. If the Board determines that the proposed alterations constitute a significant change in the appearance of the building that may conflict with its original character or architectural style, the Board may schedule a public hearing in accordance with Chapter 2.7.4 – Designation of Historic Buildings or Sites.

In determining if an exterior remodel is "significant change" the Planning Commission reviewed and approved the request using the following guidelines:

- Provide for the preservation and protection of sites and improvements within the community of Phoenix that reflect or represent elements of the City's cultural, social, economic, political, or architectural history;
- Safeguard the City's historic, aesthetic and cultural heritage as embodied and reflected in such improvements and areas;
- Complement the efforts of the Southern Oregon Historical Society, State of Oregon, and other organizations or individual efforts aimed at historical preservation;
- Foster civic pride in the beauty and accomplishments of the past;
- Carry out the provision of LCDC Goal #5.

The mural is titled "Phoenix Rising from the Ashes" and was installed in the Winter of 2021 on the east face of the Phoenix Grange Building (Phoenix Grange #779). The original approval allowed the mural to be in place for a period of 2 years and required a maintenance agreement. The mural continues to represent elements of the City's cultural, social, economic and architectural history and remains in good condition.

The procedures and standards for Council review of public art in Phoenix are contained in a portion of the "Sign Code" within the Phoenix Land Development Code (PLDC), Section 3.6.11 as follows:

3.6.11 – Public Art Program, Procedures and Standards of Review

A. The applicant shall submit a Public Art Plan for review by the Phoenix Arts Council or its designee that shall, at minimum address the following:

- 1. The location, dimensions, and method of installation or construction of the artwork.
- 2. A maintenance plan describing activities and procedures to ensure that the artwork remains in its intended condition over the course of its functional lifetime.
- 3. A sketch or other accurate representation of the artwork to be installed or constructed.
- 4. A legally binding and enforcement agreement enabling the City of Phoenix to maintain, repair, and remove the artwork if its condition violates the terms and conditions set forth in the Public Art Plan...
- B. The plan shall substantially comply with the other requirements of this ordinance (including but not limited to standards for illumination, clear vision areas, etc.), but may diverge from these standards to allow for creative, artistic expression provided that none of the artwork in the proposed plan would create conditions that are hazardous as defined within this chapter.

No changes to the original approval or artwork are requested at this time. The request is to allow the mural to remain in place for a period of 10 years.

COUNCIL GOALS SUPPORTED

Goal 1: Concise, transparent and frequent communication to build culture of respect, accountability and excellence. Leadership that is accessible, responsive and proactive.

FISCAL IMPACT

The continued placement of the mural should have no staff impacts.

RECOMMENDATION

Staff recommends Council consider the request, but for a period of less than 10 years. While there are procedures and standards for review for public art, there are no object criteria provided by which staff could evaluate the renewal request, including the time period requested.

PROPOSED MOTION

Possible motion to approve or deny the request. Any motion to approve should include direction to staff to enter into a new maintenance contract as required by the Phoenix Land Development Code.
